

RESOLUTION _____**AUTHORIZING EXPENDITURE OF AMERICAN RESCUE PLAN ACT FUNDS ON CITY OF WESTLAND EQUIPMENT PURCHASES AND PROJECTS**

At a regular meeting of the City Council of the City of Westland, County of Wayne, State of Michigan ("the City") held on the 18th day of April, 2022, the following resolution was adopted:

WHEREAS the City of Westland has received \$25,932,032 as part of the American Rescue Plan Act (ARPA) ;

WHEREAS ARPA requires that all money received by a municipality be allocated by December 31, 2024 & completely spent by December 31, 2026;

WHEREAS, the City received \$12,966,016 in ARPA funds in May of 2021;

WHEREAS, the City should receive the remaining ARPA funds in the amount of \$12,966,016 in May of 2022;

WHEREAS , The City has identified eligible projects for the allocation of the May 2021 funds in the areas listed below:

○ General Fund Support (Lost Revenue)	\$5,000,000
○ Public Safety and services vehicles & equipment	\$3,516,016
○ Affordable Housing & Senior Care/PVM	\$1,500,000
○ Building/Property Improvements - Police Dept, Golf & Ice Arena	\$1,250,000
○ Central City Park Pond Improvements	\$450,000
○ Residential Basement Flooding Mitigation Equipment	\$400,000
○ Hero Pay - all full time employees (No elected Officials)	\$350,000
○ Tree Truck/Chipper – Power Outage Mitigation	\$300,000
○ Public Broadband Infrastructure	\$200,000
▪ Total	\$12,966,016

WHEREAS, the City would adhere to all of its procurement policies & procedures for the above items; including Council authorization for the Mayor and City Clerk to execute contracts on behalf of the City.

WHEREAS, The City administration will provide a reconciliation to City Council once all items have been purchased, received and paid.

WHEREAS, the purchase of capital items especially vehicles and equipment have long lead times and other capital expenditure items need engineering and construction plans, it is necessary to authorize City administration to begin acting on these matters since time is of the essence.

THEREFORE, BE IT RESOLVED AS FOLLOWS:

City of Westland Council authorizes administration to procure and expend the following items in an amount not to exceed \$12,966,016:

○ General Fund Support (Lost Revenue)	\$5,000,000
○ Public Safety and services vehicles & equipment	\$3,516,016
○ Affordable Housing & Senior Care/PVM	\$1,500,000
○ Building/Property Improvements - Police Dept, Golf & Ice Arena	\$1,250,000
○ Central City Park Pond Improvements	\$450,000
○ Residential Basement Flooding Mitigation Equipment	\$400,000
○ Hero Pay - all full time employees (No elected Officials)	\$350,000
○ Tree Truck/Chipper – Power Outage Mitigation	\$300,000
○ Public Broadband Infrastructure	\$200,000

NOW, THEREFORE, BE IT RESOLVED THAT, the City Council of the City of Westland, Wayne County, Michigan, does hereby authorize City Administration to move forward with the above expenditures, projects and equipment planning and ordering while following City Ordinances for bidding and approval of the above and reporting back to Council upon completion of each noted category.
